Guardianship; \$311.00; + \$83.00 for service on ward and if ward is 60 years of age or older, then each relative must be served by certified mail: \$75.00 fee for each letter.

Citation by publication Sheriff's service fee \$75.00; \$8.00 Citation Fee

Contest of Will: \$202.00

Add \$8.00 per citation issued for personal service and \$75.00 per citation served in Llano County for Sheriff's service.

When citation by publication is required, publishing costs are in addition to the above and are borne by applicant.

Inventory and appraisal filed after the 90<sup>th</sup> day after the qualification of applicant is \$25.00. Plus \$2.00 for Judge's signature.

Filing annual or final account of estate, filing fee of \$25.00. Plus \$2.00 for Judge's signature on order.

Filing application for sale of real or personal property, filing fee of \$25.00. Plus \$2.00 for Judge's signature on order.

Filing of annual or final report of guardian of a person, filing fee of \$10.00. Plus \$2.00 for Judge's signature on order

For documents 25 pages in length or more for any document not listed above filed after the order approving inventory, appraisal and list of claims or after the 120<sup>th</sup> day of initial filing of action there will be a fee of \$25.00

Letters Testamentary, Letter of Guardianship, Letter of Administration \$2.00 each

Claims against an Estate \$10.00 must be paid by claimant at time of filing.
