Any such deed or other conveyance, which fails to include a mailing address of each grantee appearing in the document or attached instrument may only be filed for record with the County Clerk of the County in which the real property is situated after payment of a penalty-filing fee equal to the greater of (1) twice the statutory filing fee for the filing of such document with the County Clerk OR (2) the sum of \$25.00. *This fee is in addition to regular filing fees*.

<u>Property Code Sec. 52.0041</u>: Address requirement for recording abstract of judgment. A judgment abstracted after September 1, 1993 may not be recorded unless: (1) a mailing address of each plaintiff or judgment creditor appears on the abstract of judgment OR (2) a penalty filing fee equal to the greater of \$25.00 or twice the statutory recording fee for the abstract is paid.

<u>LGC §191.007(c)(h)</u>: Provides double the filing fee for that page if there is not a clearly identifying heading, similar to the heading on most printed forms, must be placed at the top of the first page to identify the type or kind of legal paper.

<u>LCG §191.007(e)(h)</u>: Provides double the filing fee for that page if names are not legibly typed or printed immediately under each signature.

**LCG 191.007(3):** Printed in type no smaller than 8-point type.
