

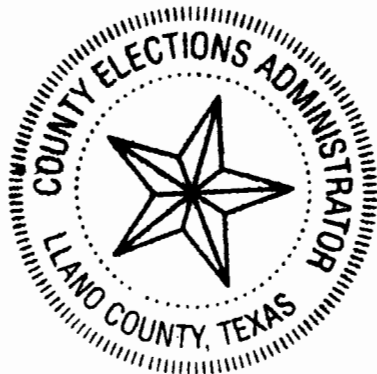



CANVASS OF GENERAL ELECTION

There were 13,728 voters in the November 5, 2024 Election, representing 74.38% turnout.
