

ORDER CALLING AN ELECTION TO CONFIRM THE CREATION OF LLANO COUNTY EMERGENCY SERVICES DISTRICT NO. 6  
AND AUTHORIZE THE IMPOSITION OF A TAX NOT TO EXCEED THE RATE  
ALLOWED BY SECTION 48-e, ARTICLE iii, TEXAS CONSTITUTION

**WHEREAS**, the Llano County Commissioners Court received PETITION FOR AN EMERGENCY SERVICES DISTRICT SEEKING TO CREATE LLANO COUNTY EMERGENCY SERVICE DISTRICT NO. 6, TO A PORTION VOTING IN PRECINCT 204 AND ALL VOTING IN PRECINCT 205, WHICH INCLUDED TOW AND BLUFFTON AREA.

**WHEREAS**, the Llano County Commissioners Court granted the Petition by executing the RESOLUTION APPROVING PETITION FOR AN EMERGENCY SERVICES DISTRICT SEEKING TO CREATE LLANO COUNTY EMERGENCY SERVICES DISTRICT NO. 6,

**IT IS THEREORE ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS COURT OF LLANO COUNTY, TEXAS that:**

- 1. An election will be held to confirm the creation of EMERGENCY SERVICES DISTRICT NO. 6 and authorize the imposition of a tax authorized by Texas Health and Safety Code Sec. 775.018;
- 2. The election shall be on the 4<sup>th</sup> day of November, 2025, which date is the next available uniform election date under Chapter 41, Texas Election Code.
- 3. The creation of the district at the election shall be by majority vote of all the voters; except that the district may not include territory in a municipality’s limits or extraterritorial jurisdiction unless a majority of the voters residing in that territory who vote at the election vote in favor of creating the district;
- 4. The boundaries of the district are set in the attached Exhibit “A”;
- 5. At the election, the below proposition shall be submitted to the qualified voters who reside in the proposed District.

**PROPOSITION**  
**(A TAX INCREASE)**

**CONFIRMATION OF THE CREATION OF LLANO COUNTY EMERGENCY SERVICES DISTRICT NO. 6 AND THE LEVY BY SAID DISTRICT OF A TAX NOT TO EXCEED TEN (10) CENTS ON THE ONE HUNDRED DOLLAR (\$100) VALUATION.**

- 6. The ballot of the election shall conform to the requirements of the Texas Election Code, as amended, and shall have printed thereon the following:

**OFFICIAL BALLOT/ BALOTA OFICIAL**

FOR  AGAINST	Confirmation of the creation of Llano County Emergency Services District NO. 6 and the levy by District of a tax not to exceed ten (.10) cents on the one hundred dollars (\$100.00) of valuation.
A FAVOR  EN CONTRA	Confirmación de la creación del Distrito de Emergencia NO. 6 de Condado de Llano la imposición por el Distrito de un impuesto que no excederd diez (0.10) centavos por cada valuacion decien dólares (\$100.00).

- 7. The COURT shall enter any such further Orders in furtherance of the Election called as it shall deem necessary and proper and as required under the Texas Election Code and Chapter 775 of the Health & Safety Code, including, but not limited to the establishment of voting and election precincts, designation of Presiding and alternate Presiding Judges, the polling place location, early voting clerk and early voting locations, the early voting ballot board and the posting and publication of the Election Notice.


