To enhance tourism and perception of the Llano County Historical Museum, the City of Llano, Llano County and the entire Hill Country.
2. Discussion and possible action to consider a grant application in the amount of \$12,800.00 from Lake Buchanan/Inks Chamber of Commerce for the operation of the Chamber Visitor Center, Llano lodging dues matching and website upgrade.
3. Discussion and possible action to consider a grant application in the amount of \$9,000.00 from Texas Hotel & Lodging Association to provide a group listing partnership with THLA to provide free legal advice and advertising for each Llano County lodging property.
