Notice is hereby given that a Regular Meeting of the above-named Commissioners Court will be held on the **30th Day of August, 2021 at 9:00 A.M.** at the Llano County JP#4 Courtroom, 2001 North State Hwy 16, Ste B., Llano, Texas, at which time the following subjects will be discussed and appropriate action taken, to-wit:

THIS BUDGET WILL RAISE MORE REVENUE FROM PROPERTY TAXES THAN LAST YEAR'S BUDGET BY \$1,425,155 WHICH IS A 12.10% INCREASE FROM LAST YEARS BUDGET. PROPERTY TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR IS \$388,535.
6. Discussion/Action to amend the proposed tax rate. (RC)
7. Discussion/Action to adopt the 2021 Tax Rate; .29574/100 - M&O Rate .27374/100 (General Fund .24674/100 Road & Bridge .02700/10); Debt Service (I&S) .02200/100. This year's levy to fund maintenance and operations expenditures exceeds last year's maintenance and operations tax levy. (RC)

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.31 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$-11.67.
