Summary:

To promote collaboration between law enforcement and mental health professionals to provide crisis intervention and crisis stabilization services to individuals in behavioral emergencies. Serve as liaison between law enforcement and community stakeholders with an interest in behavioral health services. To execute emergency detention orders for individuals who are in crisis.

Essential Duties and Responsibilities:

- Respond to calls where someone is having mental health crisis
- Execute Emergency Detention Orders when necessary
- Work with Mental Health Officials within Llano County
- Follow up with individuals that have been released from Mental Health Facilities
- On call for emergency situations
- Transport individuals to Mental Health Facilities and/or Hospitals

Other Responsibilities (Marginal Functions):

- Ensure deputies maintain a professional appearance (uniforms and vehicles)
- Public relations
- Must be flexible with hours available to work (on call)

Knowledge, Skills and Abilities:

- Good communication skills oral/written and be able to communicate effectively with individuals
- Knowledge of Sheriff's Office Policy and Procedure Manual

Education, Certificates, and Licenses:

- Must have High School Diploma or GED
- Must be a minimum (21) twenty-one years of age
- Must hold TCOLE Texas Basic Peace Officer License
- Must complete Mental Health Training

Certificate and Licenses:

- Basic TCOLE certification
- Annual firearms qualification
- Maintain the required in-service hours

Physical Demands:

- Must be able to work 12-hour shifts
- Ability to effect the lawful arrest of individuals
- Ability to act during stressful/confrontational situations
