Summary:

Transportation of inmates.

Essential Duties and Responsibilities:

- **Inmate Transport:** Safely and securely transport inmates to and from designated locations, including detention facilities, courts, medical facilities, and other authorized destinations.
- **Security and Safety:** Maintain the highest standards of safety and security during transportation, including proper restraint procedures and monitoring of inmate behavior.
- **Vehicle Maintenance:** Perform routine inspections and basic maintenance on the transport vehicle to ensure it remains in safe and operational condition.
- **Documentation:** Accurately document all inmate transports, including destinations, times, and any incidents that occur during transit.
- **Emergency Response:** Be prepared to respond to emergency situations or security threats during transport, follow established protocols and procedures.
- **Compliance:** Ensure compliance with all relevant laws, regulations, and departmental policies, including the humane treatment of inmates.

- Maintain effective communication with supervisors, fellow officers, and other law enforcement agencies to coordinate transportation schedules and ensure the smooth transport of inmates.
